

PERSONAL DATA PROCESSING NOTICE

[Information for the parties to the civil law agreement]

In connection with the enforcement of the requirements of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/WE (General Data Protection Regulation) ("RODO"), Bank Handlowy w Warszawie S.A. ("Bank") hereby informs of the rules of processing of your personal data and of your rights in connection with such processing of personal data.

I. Designation of Data Controller

The data controller of your personal data is Bank Handlowy w Warszawie S.A. with its registered office in Warsaw, ul. Senatorska 16, 00-923 Warsaw, Poland.

II. Purposes and legal basis of processing of your personal data

1. The Bank processes your personal data in order to take the necessary steps aiming at executing the instruction related to the submission of a civil law agreement at the Bank, constituting the legal basis for the Bank to perform activities related to the transfer of financial instruments, i.e. in the Bank's legitimate interest (Article 6(1)(f) of RODO) and additionally for the purposes of being compliant with legal obligations borne by the Bank in relation with conducting brokerage activities (Article 6(1) (c) of RODO), including:
 - a) purposes resulting from the implementing provisions to the Act of 29 July 2005 on Trading in Financial Instruments, in the scope of the obligation to record financial instruments on the account in connection with their transfer;
 - b) purposes resulting from the Polish Act of 1 March 2018 on Counteracting Money Laundering and Terrorist Financing (the so-called "AML Act");
 - c) purposes associated with handling actions and complaints related to services provided by the Bank in accordance with Article 5 of the Act on Handling of Complaints by Financial Market Entities and on the Financial Ombudsman of 5 August 2015, as well as handling other requests and inquiries addressed to the Bank
2. Moreover, in some situations, it is or may prove necessary to process your personal data for purposes other than specified above and required in the context of the pursuit of the Bank's legitimate interests (Article 6(1)(f) of RODO), in particular:
 - a) monitoring of telephone conversations and meetings with the Bank;
 - b) for purposes related to the Bank's risk management and internal control;
 - c) in order to prevent abuses and use of the Bank's activities for criminal purposes, including for the purpose of processing and sharing information on suspicions or detection of crimes;
 - d) if applicable, for purposes of keeping internal records of benefits given and received, conflicts of interest and violation of ethics, to the extent necessary to prevent abuse or criminal exploitation of the Bank's activity;
 - e) if applicable, for purposes related with litigation, as well as pending state authorities' proceedings and other proceedings, including the pursuit of and defense against claims;
3. In other instances, your personal data shall be processed exclusively on the basis of a previously granted consent within the scope and for the purposes specified in such consent.

III. Source of obtaining personal data

If the personal data have not been obtained directly from you, the Bank informs, that your personal data, i.e. depending on the situation - name, surname, address data, contact data, a copy of or data from an identity document or other document authorizing to act on behalf of another person, PESEL number, signature specimen, date of birth, degree of kinship with the Client have been obtained from the other party to the civil law agreement or from that party's attorneys or from other persons engaged in the Bank's activities related to the execution of the civil law agreement.

IV. Obligation to provide personal data to the Bank

To the extent in which your personal data are obtained directly from you, providing personal data results from compliance with legal obligations or is necessary to pursue purposes resulting from abovementioned legitimate interests of the Bank.

Your failure to provide all the required personal data may constitute, depending on the circumstances, an obstacle or an impediment to taking actions resulting from the execution of a civil law contract, including actions aimed at executing your instructions or other actions, if applicable.

To the extent, where personal data are being collected on the basis of consent, providing personal data is voluntary.

V. Information on recipients of your personal data

In relation to the processing of your personal data for purposes indicated in item II, your personal data may be shared with the following recipients or categories of recipients:

- a) State authorities and entities performing public tasks or acting at the direction of state authorities, to the extent and for purposes resulting from the provisions of law, e.g. the Polish Financial Supervision Authority, the General Inspector for Financial Information, National Tax Administration and other entities authorized to receive information in cases specified by law provisions
- b) entities supporting the Bank in its business processes and brokerage activities, including entities processing personal data for the Bank (the so-called data processors).
- c) other investment firms, in the event of transfer of financial instruments to an account with such investment firm.

VI. Periods of processing of your personal data

Your personal data will be processed for the period necessary for realization of purposes specified in item II, i.e. with respect to the execution of the civil law agreement, for the period until the end of its execution and after that, for the period and to the extent required by the provisions of law or for pursuing data controller's legitimate interests by the Bank in the scope stipulated in II above.

If you grant your consent to the processing of data for purposes other than indicated in item II above, your personal data will be processed until the withdrawal of such consent.

VII. Profiling and automated decision-making

Your personal data will not be used for profiling and for automated decision-making with respect to you.

Profiling should be understood as any form of automated processing of personal data, so as to evaluate certain characteristics of a natural person, in particular, to analyse or predict her/his economic situation, reliability, behavior (investment behavior in particular).

VIII. Rights of the data subject

The Bank wishes to assure you that all persons whose personal data are being processed by the Bank hold appropriate rights under RODO. Therefore, you have the following rights:

1. The right to access your personal data, including the right to obtain copies of such data;
2. The right to request rectification (correction) of your personal data when such data are inaccurate or incomplete;
3. The right to request the erasure of your personal data (the so-called "right to be forgotten") where i) the data are no longer necessary for the purposes for which they were collected or otherwise processed; (ii) the data subject objects to the processing of personal data; (iii) the data subject withdraws consent on which the processing is based and there is no other legal ground for the processing; (iv) the data are unlawfully processed; (v) the data have to be erased for compliance with a legal obligation;
4. The right to request the restriction of processing of personal data where: (i) the accuracy of the personal data is contested by the data subject; (ii) the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead; (iii) the controller no longer needs the personal data for the purposes of processing, but it is required by the data subject for the establishment, defense or exercise of legal claims; (iv) the data subject has objected to processing of the personal data - pending the verification whether the legitimate grounds of the controller override those of the data subject ;
5. The right to transfer personal data (portability) where (i) the processing is based on agreement with the data subject or on a consent granted by such person or (ii) the processing is carried out by automated means;
6. The right to object to processing of personal data, including profiling, (i) on grounds relating to your particular situation and where (ii) data processing is based on the necessity to pursue purposes resulting from legitimate interests of the Bank, referred to in II above

IX. The right to withdraw consent for personal data processing

To the extent where you have given consent for processing of your personal data, you are entitled to withdraw such consent for processing of personal data. Withdrawal of consent does not affect the lawfulness of data processing based on consent before its withdrawal.

X. The right to lodge a complaint with a supervisory authority

In case you find processing of your personal data by the Bank is infringing RODO provisions, you are entitled to lodge a complaint with the relevant supervisory authority.

XI. Transfer of personal data to entities outside the European Economic Area (EEA) or international organizations

Your personal data will not be transferred to entities situated outside the European Economic Area (EEA) or international organizations.
