# Changes in Customs Office transfer processing: a reminder

Please be reminded that in view of the Regulation of the Minister of Finance of May 13, 2015 on cash deposit and transfer order forms for payments made to Customs Office, effective from July 1 transfers to bank accounts of customs authorities should comply with the structure and content specified in the said Regulation.

From July 1, to make transfers referred to in the new regulations you will need to use the import maps and forms of the Tax Office transfers. The rules of processing payments made to customs authorities have been aligned with those currently applicable to the Tax Office transfers.
