Electronization of the process of issuing bank guarantees

We would like to remind that starting from 1 January 2019, Citi Handlowy will implement a full electronization of the process of issuing bank guarantees, i.e. the issuance of any type of guarantees in an electronic form based on an application for guarantee that may also be submitted electronically.

The written form of a guarantee will be treated as an additional form to the electronic one, and as of 1 April 2019, it will be issued against an additional fee. Until 30 March 2019, a written guarantee will be issued free of charge.

We encourage you to use the Citi Trade Portal to submit an application for guarantee.
