Basic Foreign Transfer Rules



We would like to remind you a few simple rules the following of which will help you successfully make a correct foreign/currency transfer.

1. Option of **one-time value date shortening**: select "OTHER INSTRUCTIONS" in CitiDirect and enter one of the two options below:

"VD0" – with zero at the end — Express Transfer to be settled on the same day.

"VD1" – Urgent Transfer to be settled on the next working day, at the latest.

Both options should be entered without spaces and with no additional comments or words. This service is charged according to the Fee and Commission Table or as individually negotiated.

2. Option to convert a transfer amount into other currency—the so called **Equivalent**:

To place an order to the bank to convert a transfer amount into other currency, please enter "XXX EQUIVALENT" in "OTHER INSTRUCTIONS" in CitiDirect, where XXX should be replaced with a code of a currency in which the transfer is to be made.
