A reminder about the obligation to supply personal details of company representatives and consequences of default

Please note that pursuant to the Anti-Money Laundering and Anti-Terrorism Financing Act (Journal of Laws No. 116 of 22 December 2000, item 1216) as amended and including all relevant executive acts, banks, as obligor institutions, have a statutory obligation to identify the persons placing transaction orders on behalf of their clients.
