CURRENT LIST OF BANKS PARTICIPATING IN SEPA SCHEME

We inform you that the list of the banks participating in the Single Euro Payments Area is available at https://www.ebaclearing.eu/SCT-Participants-N=877a185d-517c-4052-908c-1eb99a373f50-L=EN.aspx#top.

The list is changeable. Banks may change their manner of participation in the SEPA and there might be a slight delay before such information is published.

When processing a transfer Citi Handlowy verifies whether a beneficiary's bank is a participant of the SEPA system. If it is not, the transfer will be sent as a traditional foreign transfer and will be charged as such.

We strongly encourage you to use the above website in order to find out whether your contractors' banks are the participants of the SEPA system.

This will help avoid unexpected costs which may appear when sending money as a traditional foreign transfer.

REQUIREMENTS FOR RUBLE TRANSFERS

According to local Russian law, each Russian ruble transfer (RUB) should contain information on paid tax. If VAT is not to be paid, you should also provide such information when making a ruble transfer. Non-fulfillment of the above requirements may result in delay or failure to complete the payment.

According to SWIFT rules, the information may be provided in the following way:

CHANGES IN VAT FOR FACTORING SERVICES

Pursuant to alteration of the Goods and Services Tax Act of March 11, 2004 (by means of the Act of October 29, 2010 on the Change in the Goods and Services Tax, Journal of Laws of 2010, no. 226, item 1476 and the Act of November 26, 2010 on the Changes in Selected Acts Regarding Budget Act Implementation) – effective January 1, 2011, the Bank will be obliged to tax the remuneration for providing factoring services according to the basic rate of 23% including the costs and fees for the services provided by banks regarding the execution of the subject agreements and not only regarding the scope of operating services and receivables management (e.g. fees, commissions) which were previously charged with 22% VAT rate and also including the remuneration for the financing provided by banks (interest rates due for a bank), unless a given scope of the services has been set forth in the relevant contractual provisions.

In view of the above, we hereby kindly inform you that according to the regulations currently in force, the Bank shall issue invoices for the above mentioned receivables that will show the amount of the VAT plus appropriate amount for the services increased by current VAT rate.

The VAT invoices for the Bank's remuneration shall be issued according to previous contractual provisions and in case of the financing, the day on which the financing was provided or the receivables were fully paid off shall be deemed as the day of service provision.
