Re: Information on selection of an entity authorized to audit financial statements

Legal basis: Pursuant to paragraph 5 clause 1 point 19 of the Ordinance of the Minister of Finance dated 19th February 2009 on current and periodic information published by issuers of securities and the conditions for regarding as equivalent the information required by the law of a non-member state (Journal of Laws, No. 23, item 259, as amended),

Bank Handlowy w Warszawie S.A. (the "Bank") hereby informs that the Supervisory Board of Bank Handlowy w Warszawie S.A. on March 16, 2012 selected an entity authorized to audit financial statements – KPMG Audyt Sp. z o.o.
